**ORDINANCE NO. 319
Series of 2020**

AN ORDINANCE AUTHORIZING THE USE OF SAVINGS/UNEXPENDED BALANCES FROM OTHER ITEMS IN THE CY 2020 APPROVED ANNUAL BUDGET TO AUGMENT APPROPRIATIONS WITHIN THE SAME EXPENSE CLASS OF THE AURORA MEMORIAL HOSPITAL OF THE PROVINCIAL GOVERNMENT OF AURORA IN THE TOTAL AMOUNT OF PHP 200,000.00

WHEREAS, the Provincial Acting Governor, Hon. Christian M. Noveras, in his letter dated 13 March 2020 is requesting for the enactment of an Ordinance authorizing the realignment of PhP200,000.00 from items in the approved CY 2020 Annual Budget to augment other item within the same expense class;

WHEREAS, Section 336 of RA 7160 or the Local Government Code of 1991 authorizes the use of savings from appropriations in the approved annual budget to augment other item within the same expense class;

NOW THEREFORE, on motion of Hon. Lordan B. Roxas unanimously seconded;

BE IT ORDAINED, by the Sangguniang Panlalawigan, in session assembled that:


SECTION 1. Source of Funds.-The source of funds for the intended expenditure under this ordinance in the amount of PhP200,000.00 shall come from the object of expenditure (Consultancy Services) considered as unexpended balance/savings of the Aurora Memorial Hospital (AMH);

SECTION 2. Use of Funds.- The aforementioned amount as realigned from the aforesaid object of expenditures shall be used to augment the current appropriations for Training Expenses under the Aurora Memorial Hospital:


SECTION 3. Effectivity.-This Ordinance shall take effect upon approval.


