**ORDINANCE NO. 332**

**AN ORDINANCE AUTHORIZING THE USE OF SAVINGS/UNEXPENDED BALANCES FROM APPROPRIATION OF THE OFFICE OF THE SANGGUNIANG PANLALAWIGAN UNDER THE APPROVED CY 2020 ANNUAL BUDGET TO AUGMENT OTHER ITEMS WITHIN THE SAME EXPENSE CLASS**

**WHEREAS,** the Sangguniang Panlalawigan intended to use the unexpended balances from appropriation for Maintenance and Other Operating Expenses and Special Purpose Appropriations under the CY 2020 Annual Budget to augment other items needing additional appropriation;

**WHEREAS,** the proposed realignment is in consonance with Section 336 of RA 7160 or the Local Government Code of 1991 authorizing the use of savings from appropriations in the approved annual budget to augment other items within the same expense class;

**NOW THEREFORE,** on motion of Hon. Jennifer A. Arana unanimously seconded;

**BE IT ORDAINED** by the Sangguniang Panlalawigan in session duly assembled that:

**SECTION 1. Sources of Fund.-** The fund for the intended expenditures under this Ordinance in the amount of P 1,069,042.00 shall come from the savings/unutilized allocations under the approved Annual Budget for CY 2020, free from any obligation or encumbrance, as follows:


