A RESOLUTION ADOPTING PDC EXECOM RESOLUTION NOS. 04, 05 and 06, ALL SERIES 2020 OF THE PROVINCE OF AURORA

WHEREAS, presented for consideration of the body were the hereunder entitled PDC ExeCom Resolutions, as follows:

a) PDC ExeCom Resolution No. 04 – A RESOLUTION ADOPTING AND APPROVING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRRMC) RESOLUTION NUMBER 03 SERIES 2020 ENTITLED "A RESOLUTION APPROVING THE ADDITIONAL FUND SUPPORT FOR PREVENTION AND CONTROL OF HUMAN EMERGING AND RE-EMERGING INFECTIOUS DISEASE OUTBREAK IN THE PROVINCE OF AURORA PRIMARILY CORONAVIRUS DISEASE 2019 (COVID-19) AMOUNTING TO TEN MILLION PESOS (PHP10,000,000.00) CHARGEABLE AGAINST SPECIAL TRUST FUND OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND;

b) PDC ExeCom Resolution No. 05 – A RESOLUTION APPROVING THE ADDITIONAL FUNDS FOR DONATIONS AMOUNTING TO PHP 20,000,000.00 AND SPA-ASSISTANCE IN TO INDIVIDUAL IN CRISIS SITUATION (SPA-AICS) AMOUNTING TO PHP5,000,000.00 FOR INCLUSION IN THE CY 2020 ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF AURORA TO BE KNOWN AS ADDENDUM NUMBER 003 SERIES OF 2020; and

c) PDC ExeCom Resolution No. 06 – A RESOLUTION APPROVING THE ALLOCATION OF COVID-A9 PAY AMOUNTING TO TEN MILLION PESOS (PHP 10,000,000.00) AND INCLUSION TO CY 2020-2022 PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM AND CY 2020 ANNUAL INVESTMENT PROGRAM (AIP) PURSUANT TO ADMINISTRATIVE ORDER NO. 26 BY THE PRESIDENT OF THE PHILIPPINES AND DEPARTMENT OF BUDGET AND MANAGEMENT BUDGET CIRCULAR NUMBER 2020-1 TO BE KNOWN AS ADDENDUM 004 SERIES OF 2020;

WHEREAS, said PDC Resolutions were anchored and in pursuance to Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 designating Local Government Units (LGUs) to ensure the protection and promotion of health and safety within their territorial jurisdiction which are essential to the promotion of general welfare;

NOW THEREFORE on motion of Honorable Jennifer A. Arana unanimously seconded;


