A RESOLUTION GRANTING AUTHORITY TO DR. VLADIMYR F. ENRIQUEZ, AMH CHIEF, TO SIGN ON BEHALF OF AURORA MEMORIAL HOSPITAL, A MEMORANDUM OF AGREEMENT WITH PHILHEALTH RE: HEALTH CARE PROVIDER'S INTERIM REIMBURSEMENT MECHANISM (IRM) UNDER FORTUITOUS EVENT

WHEREAS, in his letter dated 16 April 2020, Honorable Gerardo A. Noveras, Governor, has requested urgent passage of a resolution granting authority to Dr. Vladimyr F. Enriquez, AMH Chief to enter into, on behalf of the hospital, a Memorandum of Agreement with PhilHealth concerning the Interim Reimbursement Mechanism (IRM) under Fortuitous Event;

WHEREAS, in response to requests from Health Care Institutions (HCI) of fortuitous stricken areas for additional aid to remain financially viable and to continuously serve the health care needs of affected Philhealth beneficiaries, PhilHealth immediately instituted remedial measures specifically the Interim Reimbursement Mechanism (IRM) to pay for the health care services provided to PhilHealth beneficiaries by accredited healthcare institutions;

WHEREAS, this Agreement necessitates authority for Dr. Vladimyr F. Enriquez as Chief of Aurora Memorial Hospital to enter and sign into the subject Health Care Provider's Interim Reimbursement Mechanism (IRM) under Fortuitous Event;


NOW THEREFORE, on motion of Honorable Mariano C. Tangson unanimously seconded;
