**RESOLUTION NO. 145**

**A RESOLUTION RESPECTFULLY REQUESTING HON. GERARDO A NOVERAS, PROVINCIAL GOVERNOR TO GRANT FINANCIAL ASSISTANCE TO ALL SANGGUNIANG KABATAAN OFFICIALS, IDENTIFIED AS BARANGAY FRONTLINERS IN SUCH AMOUNT AS THE PROVINCIAL GOVERNOR MAY GRANT, SUBJECT TO THE AVAILABILITY OF FUNDS**

**WHEREAS,** under the declaration of a Luzon-wide Enhanced Community Quarantine, Sangguniang Kabataan Officials are charged with numerous duties and responsibilities as frontliners to prevent the spread of COVID-19 in their areas of jurisdiction;

**WHEREAS,** the Sangguniang Kabataan Reform Act (Republic Act 10742) only grants honorarium to Sangguniang Kabataan Chairmen, leaving an expressed provision as to the honoraria of SK Members, SK Secretaries and SK Treasurers;

**WHEREAS,** in gratitude and encouragement of the services rendered at the height of the Luzon-wide Enhanced Community Quarantine, where they have put their time and efforts on the line to somehow provide essential needs and others will stay safe;


**NOW THEREFORE,** on motion of Hon. Jovene Mike B. Alpuerto, unanimously seconded;

**BE IT RESOLVED,** as it is hereby resolved to request Hon. Gerardo A. Noveras, Provincial Governor, to grant financial assistance to all Sangguniang Kabataan Officials, identified as Barangay Frontliners, in such amount as the Provincial Governor may grant, subject to the availability of funds;


**RESOLVED FURTHER**, that this Resolution be furnished to the Office of the Provincial Governor, for information and appropriate action;
