NOVERAS, PROVINCIAL GOVERNOR, TO ASSURE PBGEN RHODEL O SERMONIA THAT PERSONNEL OF AURORA POLICE PROVINCIAL OFFICE WHO MAY BE FOUND SUSPECT, PROBABLE, CONFIRMED OR RECOVERING FROM COVID-19 CAN BE ACCOMMODATED AND TREATED IN THE QUARANTINE FACILITIES IN THE PROVINCE OF AURORA

WHEREAS, a letter dated 27 April 2020 of Brig. General Rhodel O Sermonia, RD PRO3 addressed to Honorable Governor Gerardo A. Noveras informs the latter that the PNP will be conducting a mass testing of its deployed personnel in the Province for COVID-19;

WHEREAS, included in the said letter is a request that personnel of Aurora Police Provincial Office who may found suspect, probable, confirmed or recovering from COVID-19 disease be accommodated and provided the necessary treatment in the quarantine facilities in the province;

NOW THEREFORE, on motion of Hon. Nicasio M. Salamera, unanimously seconded;

BE IT RESOLVED, as it is hereby resolved, to request the Honorable Gerardo A.
