A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW THE MUNICIPAL ORDINANCE NO. 028 – 2019 OF BALER, AURORA, ENTITLED “AN ORDINANCE PROVIDING FREE DOSES OF ANTI-RABIES IMMUNIZATION TO INDIGENT RESIDENTS OF THE MUNICIPALITY OF BALER WHO ARE EXPOSED TO POTENTIALLY RABID ANIMALS AND PROVIDING FUNDS THEREOF”

WHEREAS, the SP Committee on Laws and Legal Matters and SP Committee on Health and Sanitation, to which was referred the Municipal Ordinance No. 028 -2019 of the Municipality of Baler, Aurora, have evaluated the same in a committee hearing held for the purpose;

WHEREAS, upon perusal of the ordinance it was agreed upon by the joint committees that the subject ordinance is within the scope of the prescribed powers of the Sangguniang Bayan to enact pursuant to the provisions of the Local Government Code;

WHEREAS, the body affirmed and concurred with the recommendations in the attached committee report submitted by the abovementioned committees;

NOW THEREFORE, on motion of Hon. Nicasio M. Salamera, unanimously seconded;

BE IT RESOLVED, as it is hereby resolved, to declare valid and consistent with law the Municipal Ordinance No. 028 – 2019 of Baler, Aurora, entitled “AN ORDINANCE PROVIDING FREE DOSES OF ANTI-RABIES IMMUNIZATION TO INDIGENT RESIDENTS OF THE MUNICIPALITY OF BALER WHO ARE EXPOSED TO POTENTIALLY RABID ANIMALS AND PROVIDING FUNDS THEREOF”;


