2. Some amount of PPAs under CY 2020 AIP exceeds from the amount as appearing in the CY 2020-2022 LDIP; and
3. There were some PPAs which were not allowed under the 20% Development Fund as per Joint Memorandum Circular No. 2017-1 dated February 22, 2017.

WHEREAS, the said municipality may take into consideration for compliance, submission of the necessary required documents, as embodied in the committee report which is attached and made integral part of this Resolution;


