WHEREAS, submitted for review by the Sangguniang Panlalawigan was Municipal Ordinance No. 105, series 2019 of Dingalan, Aurora entitled "Adopting and Implementing the Philippine Plan of Action for Nutrition in the Municipality of Dingalan, Aurora";

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 is the country's framework plan for nutrition and the municipality of Dingalan, Aurora is of the belief that by adopting and implementing the PPAN, child and maternal mortality particularly in Dingalan, Aurora, will be reduced;

WHEREAS, as it lays out target, directions, and priority actions to address the nutritional problems and achieve set targets in the municipality of Dingalan, Aurora, this august body interposes no objection, provided that the policy contents and guidelines stipulated under Section 4 of the submitted Ordinance shall be efficiently and effectively implemented;
