A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW THE MUNICIPAL ORDINANCE NO. 004-2019 OF THE MUNICIPALITY OF SAN LUIS, AURORA ENTITLED "AN ORDINANCE DECLARING NOVEMBER AS MUNICIPAL CHILDREN'S MONTH IN THE MUNICIPALITY OF SAN LUIS, AURORA, AMENDING FOR THE PURPOSE SECTION 27 OF MUNICIPAL ORDINANCE NO. 2015-004, AND SECTION 44 AND SECTION 45 OF MUNICIPAL ORDINANCE NO 009(A)-2017"

WHEREAS, the SP Committee on Social Welfare, Women, and Family and the SP Committee on Laws, Ordinances, and Legal Matters to whom was referred the Municipal Ordinance No. 004-2019 of the Municipality of San Luis, Aurora has considered the same in a committee hearing held for the purpose;

WHEREAS, the body affirmed and concurred with the following recommendations submitted by the abovementioned committees:

1. In Section 3, in lieu of the MSWDO ,the MCPC can instead take the lead in all the activities, programs, and projects of the one-month children celebration;
2. A section for the formulation of the Implementing Rules and Regulation by the MCPC for the said celebration can be added after Section 3 and before the Repealing Clause.

NOW THEREFORE, on motion of Hon. Jennifer A. Araña, unanimously seconded,




