RESOLUTION NO. 66

A RESOLUTION DECLARING VALID AND OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 6, SERIES 2019 OF MARIA AURORA, AURORA AUTHORIZING THE FY 2019 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY, SUBJECT TO SOME CONDITIONS

WHEREAS, submitted for review by the Sangguniang Panlalawigan was Appropriation Ordinance No. 6, series of 2019 of Maria Aurora, Aurora authorizing its CY 2019 General Fund Supplemental Budget No. 5 involving a total appropriation of Php 6,290,000.00;

WHEREAS, evaluation of the submitted budget through the SP Committee on Finance, Budget and Appropriations with the assistance of the Local Finance Committee showed substantial compliance with the provisions of RA 7160 or the Local Government Code of 1991 and with the existing rules and guidelines issued by the Department of Budget and Management (DBM);

NOW THEREFORE, on motion of Hon. Jennifer A. Araña duly seconded by Hon. Lordan B. Roxas, Hon. Nicasio M. Salamera, Hon. Isidro P. Galban, Hon. Rafael M. De Mayo and Hon. Philip Butch M. Bautista;

BE IT RESOLVED, as it is hereby resolved to declare valid and operative in its entirety Appropriation Ordinance No. 6, series of 2019 of Maria Aurora, Aurora authorizing the CY 2019 Supplemental Budget No. 5 subject to the following conditions:

1. The reversion/realignment of appropriation shall not in anyway prejudice legal or substantive rights that have already accrued therein;

2. The payment of C N A incentives shall be disbursed in accordance with DBM Budget Circular No. 2019-5 dated November 7, 2019; and


3. The herein review action does not authorize any item/s of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law anchored on a Supreme Court decision in the case of Magtajas vs. Pryce Properties Corp., the dispositive portion of which states that "for an ordinance to be valid, it shall not violate any law or statute" (Magtajas vs. Pryce Properties Corp., Inc., 234 SCRA 255);

RESOLVED FURTHER, to furnish copy of this resolution the Office of the Municipal Mayor and the Sangguniang Bayan of Maria Aurora, Aurora thru the Presiding Officer of Baler, Aurora for their information and guidance;


