RESOLUTION NO. 97

A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW THE MUNICIPAL ORDINANCE NO. 035, SERIES OF 2019 ENTITLED "DECLARING THE MONTH OF JUNE 2020 AND EVERY YEAR THEREAFTER AS DENGUE AWARENESS AND PREVENTION MONTH IN THE MUNICIPALITY OF CASIGURAN, AURORA AND APPROPRIATING FUNDS FOR THE PURPOSE, EXCEPT SECTION 6 THEREOF

WHEREAS, for review and evaluation of the Sanggunian was Municipal Ordinance No. 035, series of 2019 entitled Declaring the Month of June 2020 and Every Year Thereafter as Dengue Awareness and Prevention Month in the Municipality of Casiguran, Aurora and Appropriating Funds for the Purpose";

WHEREAS, the municipality is of the belief that community awareness and participation is necessary in combating dengue epidemic as the Local Government needs to intensify its campaign by setting aside a certain period every year to bring to focus this epidemic and its prevention;

WHEREAS, the submitted Ordinance was found to be valid and within the powers of the Sangguniang Bayan to enact except Section 6 providing roles of Barangay as the Sangguniang Bayan has only supervisory power and not power of control over the barangay;


NOW THEREFORE, on motion of Hon. Jason G. Martinez duly seconded by Hon. Jennifer A. Araña and Hon. Lordan B. Roxas;

BE IT RESOLVED, as it is hereby resolved to declare valid and consistent with law the Municipal Ordinance No. 035, series of 2019 declaring the Month of June 2020 and Every Year thereafter as Dengue Awareness and Prevention Month in the Municipality of Casiguran, Aurora and Appropriating Funds for the Purpose, except Section 6 thereof that provides "Roles of the Barangay";


RESOLVED FURTHER, to furnish copy of this resolution the Office of the Municipal Mayor and the Sangguniang Bayan for information and reference.
