**AN EXECUTIVE ORDER RECONSTITUTING THE LOCAL ROAD MANAGEMENT TEAM (LRMT)
OF THE PROVINCIAL GOVERNMENT OF AURORA, AMENDING THEREFORE
EXECUTIVE ORDER NO. 19-0027 SERIES OF 2019 ISSUED ON AUGUST 15, 2019**

WHEREAS, the KALSADA Program, renamed Conditional Matching Grant to Provinces (CMGP) provides grant to provinces for the upgrading, improvement and rehabilitation of provincial roads;

WHEREAS, Joint Memorandum Circular 2017-002 dated 26 April 2017 issued by the Department of Interior and Local Government (DILG) and the Department of Budget and Management (DBM) provides guidelines for the implementation of the CMGP;

WHEREAS, the Province of Aurora is a beneficiary of the CMGP;

WHEREAS, in order for the province to be granted funds, the creation of a Local Road Management Team (LRMT) which shall take the lead in implementing road repair, rehabilitation and improvement within its jurisdiction is a requisite;

WHEREAS, the Provincial Government of Aurora LRMT was created, but a need for the reconstitution of its membership is necessary;

NOW, THEREFORE, I, GERARDO A. NOVERAS, Governor of the Province of Aurora, by virtue of the powers vested in me by law, hereby ordain the following:
