RESOLUTION NO. 168

A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW EXECUTIVE ORDER NO. 2020-037, SERIES 2020 ISSUED BY HON. RICARDO A. BITONG, MUNICIPAL MAYOR OF CASIGURAN, AURORA

WHEREAS, for review by this August Body was the submitted Executive Order No. 2020-037, series 2020 of the Municipality of Casiguran, Aurora entitled "An Order Adopting Section 3 and Section 5 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases-National Government dated April 29, 2020, and Revoking the Administrative Order No. 2020-1011-001, Subject: Extended Enhanced Community Quarantine (ECQ) and Executive Order No. 2020-036, series 2020 dated April 23, 2020, Subject: Window Hours, both issued by the Municipal Mayor of Casiguran, Aurora, Philippines";

WHEREAS, perusal of the Executive Order showed that the same was in accordance with the IATF declaration stating the Province of Aurora as "Low-Risk Area in Luzon" thereby placing the entire province under the General Community Quarantine (GCQ);

WHEREAS, the municipality deemed it necessary to revoke the Administrative Order No. 2020-1011-001 dated 30 April 2020 to adopt Sections 3 and 5 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines and other necessary measures in the municipality to address the recent COVID-19 developments;

WHEREAS, the said Executive Order is issued to direct all local officials to support the mandate of the law through higher authorities and align their actions with the National Strategy Framework;


NOW THEREFORE, on motion of Hon. Jesus V. Palmero unanimously seconded;

BE IT RESOLVED, as it is hereby resolved to declare valid and consistent with law Executive Order No. 2020-037, series 2020 issued by Hon. Ricardo A. Bitong, Municipal Mayor of Casiguran, Aurora;


RESOLVED FURTHER, to furnish a copy of the resolution to the Office of the Municipal Mayor of Casiguran, Aurora;
