RESOLUTION NO. 223

A RESOLUTION AUTHORIZING HON. GERARDO A. NOVERAS, PROVINCIAL GOVERNOR TO ENTER INTO AN AGREEMENT WITH THE DOH REGIONAL OFFICE CENTRAL LUZON FOR HEALTH DEVELOPMENT PERTAINING TO MEDICAL ASSISTANCE TO INDIGENT AND POOR PATIENTS UNDER THE MEDICAL ASSISTANCE PROGRAM (MAP) THRU THE MARIA AURORA COMMUNITY HOSPITAL (MACH) AND THE AURORA MEMORIAL HOSPITAL (AMH)

WHEREAS, this august body is in receipt of the letter dated 20 July 2020 of Hon. Gerardo A. Noveras, Provincial Governor requesting passage of a resolution authorizing him to enter into an agreement with the DOH Regional Office Central Luzon for Health Development for the Medical Assistance Program (MAP) for the hereunder hospitals, namely:

1. Maria Aurora Community Hospital (MACH) amounting to PhP 990,00.00;
2. Aurora Memorial Hospital (AMH) amounting to PhP 1,485,000.00;

WHEREAS, the responsibilities and obligation of the concerned parties are clearly stipulated in the submitted MOA, and that both parties agreed to comply with the existing implementing guidelines of MAP as stated in the Department Memorandum (DM) Issuance No. 2018-0115 pertaining to reiteration of Administrative Order (AO) No. 2017-0003 entitled "Guidelines for the Implementation of the 2017 Medical Assistance Program in DOH Hospitals and other Selected Government Health Facilities and its Amendments and Clarifications" and observe the Special Provision No. 7 of the GAA 2018 for assistance to indigent patients;

BE IT RESOLVED, as it is hereby resolved to authorize the Hon. Gerardo A. Noveras, Provincial Governor to enter into an agreement with the DOH Regional Office Central Luzon for Health Development pertaining to medical assistance to indigent and poor patients under the Medical Assistance Program (MAP) thru Maria Aurora Community Hospital (MACH) and Aurora Memorial Hospital (AMH);
