RESOLUTION NO. 256

A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT TO PROVIDE GUIDELINES AND ISSUANCES UPGRADING THE ENTRY SALARY LEVEL OF MEDICAL OFFICERS IN THE HOSPITALS UNDER THE SUPERVISION AND MANAGEMENT OF LOCAL GOVERNMENT UNITS (LGUs)

WHEREAS, medical professionals have long been neglected particularly their salaries and benefits vis-a vis the job they perform in their fields of expertise;

WHEREAS, with this pandemic, it is a fact that our health workers particularly our medical officers continue to sacrifice their lives in the service of the people on health concerns caused by COVID-19;

WHEREAS, the current salary grade for a Medical Officer III for 3rd class provinces like Aurora Province is SG 21 which corresponds to about PhP 60,000.00 per month only;

WHEREAS, there is a need to reclassify and upgrade the salary of medical officers in the hospitals under the supervision and management of LGUs to compensate their invaluable services;


NOW THEREFORE, on motion of Hon. Mariano C. Tangson unanimously seconded;

BE IT RESOLVED, as it is hereby resolved to request to the Department of Budget and Management to provide guidelines and issuances upgrading the entry salary level of medical officers in the hospitals under the supervision and management of Local Government Units (LGUs) from Salary Grade 21 to Salary Grade 24;


RESOLVED FURTHER, to furnish copy of this resolution to the Department of Budget and Management and Office of the Governor through the Local Health Board-Aurora Province for information and reference;
