A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW AND WITHIN THE PRESCRIBED POWERS OF THE LOCAL CHIEF EXECUTIVE TO ISSUE EXECUTIVE ORDER NOS. 131, 132, 134 AND 135, ALL SERIES OF 2020 ISSUED BY HON. SHIERWIN H. TAAY, MUNICIPAL MAYOR OF DINGALAN, AURORA

WHEREAS, submitted for review by the Sangguniang Panlalawigan were the hereunder Executive Orders issued by Hon. Shierwin H. Taay, Municipal Mayor of Dingalan, Aurora:

- a. Atas Tagapagpaganap Blg. 131, Serye 2020 ng Bayan ng Dingalan, Aurora na may titulong "Reorganization of Municipal Disaster Risk Reduction and Management Council";
- b. Atas Tagapagpaganap Blg. 132, Serye 2020 ng Bayan ng Dingalan, Aurora na may titulong "Reorganization of Municipal Incident Command System (MICS), Structure, Composition and Defining Its Team Functions as an On-scene Disaster Response and Management Mechanism, and is Activated Only in Response to Disasters on Emergencies and Situations Approaching Crisis Level";
- c. Atas Tagapagpaganap Blg. 134, Serye 2020 ng Bayan ng Dingalan, Aurora na may titulong "An Order Reorganizing the Dingalan Search and Rescue Team"; and
- d. Atas Tagapagpaganap Blg. 135, Serye 2020 ng Bayan ng Dingalan, Aurora na may titulong "An Executive Order to Execute the Functionality of the Disaster Operation Center 24/7".

WHEREAS, perusal of the aforementioned Executive Orders issued by Hon. Shiewin H. Taay, Municipal Mayor of Dingalan, Aurora showed that the said Executive Orders were valid and consistent with law and within the prescribed powers of the Local Chief Executive to issue pursuant to the Local Government Code of 1991;


