A RESOLUTION DECLARING VALID AND CONSISTENT WITH LAW RESOLUTION NOS. 2020-062 AND 2020-063 OF DINALUNGAN, AURORA, APPROVING AND ADOPTING CY 2002-2022 LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND CY 2021 ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF DINALUNGAN, AURORA


