



EXECUTIVE ORDER No. 2021-0013

**CREATION OF TECHNICAL WORKING GROUP UNDER AURORA
PROVINCIAL STRATEGIC PERFORMANCE MANAGEMENT TEAM
(TWG-APSPMT)**

WHEREAS, CSC Resolution No. 1200481 promulgated on 16 March 2021 states that “there shall be established a performance management system, which shall be administered in accordance with rules, and regulations and standards promulgated by the Commission for all officers and employees in the career service. Such performance evaluation system shall be administered in such manner to continually foster the improvement of individual employee efficiency and organizational effectiveness”;

WHEREAS, Executive Order No. 2020-0041 series of 2020 was issued reconstituting the Aurora Provincial Strategic Performance Team (APSPMT) to oversee the implementation of Strategic Performance Management System (SPMS) within the Provincial Government of Aurora (PGA);

WHEREAS, the creation of a mechanism that ensures that the employees achieve the objectives set by the organizations as stipulated in its strategic plan is essential:

WHEREAS, as part of the mechanism to ensure the cascading of SPMS in all offices and for the APSPMT to perform its functions and responsibilities to the fullest, there is a need to create a technical working group under APSPMT;

NOW THEREFORE, in due consideration of the foregoing premises, I, **GERARDO A. NOVERAS**, Provincial Governor, by virtue of the powers vested in me by law do hereby create the **Technical Working Group under Aurora Provincial Strategic Performance Management Team (TWG-APSPMT)**.

Section 1. Composition of the Technical Working Group. The TWG shall be composed of the following:

Section 2. Functions, Duties and Responsibilities. The TWG shall perform the following duties and responsibilities but not limited to:

2.1 Provide reorientation for SPMS together with the Human Resource Management Office and APSPMT;



2.2 Provide technical assistance to the APSPMT for the review of DPCR Targets and Accomplishments;

2.3 Provide review/technical assistance to different focal person of each offices for the proper accomplishment of IPCR; and


2.4 Perform other duties and functions as may be assigned by the APSPMT.

SECTION 3. Repealing Clause. All issuances inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 4. Separability Clause. If, for any reason, any part or provision of this Order is declared invalid or unconstitutional, any part or provision not affected thereby shall remain in full force and effect.

SECTION 5. Effectivity. This Executive Order shall take effect immediately.
